Office of Child and Youth Protection

The Office of Child & Youth Protection is responsible for implementing and overseeing the full archdiocesan compliance of the Charter for the Protection of Children and Young People (Charter). The Charter is a comprehensive set of procedures originally established by the United States Conference of Catholic Bishops (USCCB) in June 2002, for addressing allegations of sexual abuse of minors by Catholic clergy. The Charter also includes guidelines for reconciliation, healing, accountability, and prevention of future acts of abuse.

To Promote Healing and Reconciliation with Victims/Survivors of Abuse

Part One

The wording of the Charter is very clear on the importance the bishops' place on their responsibility to help victims' healing and reconciliation. It states, "The first obligation of the Church with regard to the victims is for healing and reconciliation." During 2021-2022*, healing outreach to victim/survivors in the Archdiocese of Atlanta included covering the cost of therapy and The Way Healing Retreats. Also during 2021-2022*, ongoing healing outreach was provided for 7 victims/survivors who reported abuse from previous audit periods.

To Guarantee an Effective Response to Allegations of Sexual Abuse of Minors

Part Two

All dioceses are to report all allegations of sexual abuse of minors to public authorities.** All clergy who have been found guilty or admitted guilt are permanently removed from ministry. There are clear standards of behavior and appropriate boundaries for all clergy, employees and volunteers. The Safe Environment policies are outlined on the Archdiocesan website. In the spirit of transparency and the hope of continued healing for survivors of abuse, the archdiocese continues to update the published list on our webpage of priests, deacons, seminarians and religious credibly accused of sexual abuse of a minor as new information becomes available.

To Ensure the Accountability of Our Procedures

Part Three

The mission of the USCCB Committee for the Protection of Children and Young People is to advise the bishops on all matters related to child and youth protection. Each diocese has a review board to advise its bishop in his assessment of allegations of abuse by clergy and in his determination of an accused cleric's suitability for ministry. The Archdiocese of Atlanta's review board meets quarterly and is composed of at least five laypersons of integrity and good judgment in full communion with the Church. Furthermore, dioceses in the United States undergo an annual audit conducted by an outside auditor. In June 2022, the Archdiocese of Atlanta participated in the Charter compliance data audit conducted by StoneBridge Business Partners. The auditors found the Archdiocese of Atlanta in full compliance with the Charter for the nineteenth straight year. A national Annual Report on the implementation of the Charter, which is prepared and issued by the Secretariat of Child and Youth Protection for the National Review Board and the USCCB and provides an annual review of implementation statistics from all the dioceses in the United States. The Archdiocese of Atlanta also participated in the 2022 annual statistical data gathering by the Georgetown University-based Center for Applied Research in the Apostolate (CARA).



To Protect the Faithful in the Future Part Four

The Archdiocese of Atlanta trains clergy, employees and volunteers to create and maintain safe environments for children. The backgrounds of clergy, employees and volunteers were evaluated to determine if someone should not be allowed to minister to children and young people. During 2021-2022*, the Archdiocese of Atlanta trained more than 21,490 children in grades K-12 in Archdiocesan Catholic schools and parish Religious Education programs through the age appropriate and faith-based program, VIRTUS *Empowering God's Children*. In addition, more than 34,000 adults attended VIRTUS *Protecting God's Children* 3-hour, in-person training sessions in our Archdiocese.



Child Protection Efforts Costs

Compliance with the Charter represents a significant financial commitment in the Archdiocese of Atlanta. In 2020-2021*, within the Archdiocese of Atlanta, the cost of the various programs and measures outlined herein totaled \$349,572. The Archdiocese also provided financial assistance to victims and their families for medical and counseling services totaling \$197,896.

**All suspected child abuse must be reported to the Department of Family and Children Services (DFCS) 1-855-422-4453 (1-855-GA CHILD) and the Supervisor of the parish or school (pastor or principal). If the allegation of abuse involves a member of the clergy, employee or volunteer of the Archdiocese of Atlanta, also contact the Office of Child and Youth Protection during business hours or use the archdiocesan 24-hour abuse reporting line at 1-888-437-0764. The silence must be broken for the healing to begin.









THE LIFE OF THE CHURCH


The parishes of the archdiocese are a wonderful tapestry of God's people. Each has a unique history of clergy and religious, parishioners, staff and events. Our parishes are supported through the stewardship of their parishioners. Beginning with the realization that all gifts are from God, parishioners contribute their time, talent and treasure. The health of each parish has multiple facets, and this report focuses on only one, finances.

Each pastor is aided by a parish finance council to administer the financial affairs of the parish. Annually, each pastor and his parish finance council submit and certify their financial statements to the archbishop.

Each pastor and his parish finance council render a report to their parishioners on the financial condition of their parish. We collect these reports and post them on our website. Parishioners should take an active interest in understanding the administration of the temporal affairs of their parishes. Materials, including "Best Practices for Parish and School Accounting," are available on the archdiocesan website.





A PARISHIONER'S GUIDE TO UNDERSTANDING FINANCES

Stewardship is the responsibility of all parishioners. In order to be good stewards, parishioners should possess a basic understanding of parish financial operations. This understanding provides opportunities to further serve your parish.

The questions on the right are designed to assess your knowledge of parish finances and provide a guide for discussion with your parish leaders. While each can be answered with a "yes" or "no," these questions are starting points for richer discussions about financial stewardship in the parish.

It is widely accepted that an active, well-informed parish finance council strengthens accountability and assists the pastor with his responsibilities. These questions pay particular attention to parish finance councils. We publish our Parish Finance Council Guidelines on our website at:

LEADERSHIP ROUNDTABLE

- 1. Does my parish have a finance council?
- 2. Does my parish finance council meet regularly and are the members' professional backgrounds appropriate for service on the finance council?
- 3. Does my parish/parish finance council publish the annual budget and are parish officials available to discuss the budget?
- 4. Does my parish routinely publish statistics including: number of registered parishioners, collection levels and school enrollment, along with an annual comprehensive financial statement that includes revenues, expenses and a balance sheet?
- 5. Does my parish include statistics from prior years for comparison and to identify trends?
- 6. Does my parish release quarterly or semi-annual "budget updates" that show actual revenues and expenses in comparison to the approved budget?
- 7. Does my parish have a rainy day or capital savings account?
- 8. Does my parish have policies on conflicts of interest, protection of whistleblowers as recommended by the United States Conference of Catholic Bishops Accounting Practices Committee?
- 9. Is there a regularly scheduled audit of the parish that is conducted by an independent outside auditor?
- 10. Is there an annual diocesan/parish questionnaire that assesses the parish's financial controls and health? Is this document reviewed by the parish finance council and acted upon?
- 11. Are parish buildings inspected by a competent building inspector periodically for routine maintenance? Are the inspection results taken into account when budgeting?
- 12. Does my parish follow diocesan guidelines for handling offertory collections, such as rotating teams of collection counters?
- 13. Are there oversight policies for receipt/handling and disbursement of parish funds handled by individuals?
- 14. Are bank and other account statements received and reviewed independently by more than one individual?
- 15. Are the individuals handling financial responsibilities in my parish cross-trained so that if one becomes incapacitated, another may perform that function?

In 2008, Georgia's elected officials had extraordinary vision in passing the Qualified Education Expense Credit law, which provides families in the state with access to better educational opportunities for their children. As Georgia's only Catholic student scholarship organization, GRACE Scholars has provided thousands of children throughout our state with financial aid to attend one of our 32 partner Catholic schools. GRACE Scholars is a Georgia nonprofit corporation and tax exempt 501(c)(3) organization. The mission of GRACE Scholars is to provide children from families with financial need throughout the state of Georgia with greater opportunities to secure a quality Pre-K through grade 12 Catholic education. Our goal is to afford qualifying families a quality education while providing donors with an opportunity to use their tax dollars toward Catholic school scholarships.

This school year 1,076 students in our partner schools throughout Georgia are GRACE scholar recipients. They represent every demographic category and are found at each Archdiocesan and Diocese of Savannah school. Their scholarships amounted to \$3,753,698. Catholic education is not a low-priced investment, but it is a proven instrument for meaningful learning and preparing students for a bright future. Catholic schools excel in academics and in developing a solid faith-based foundation. Our schools are Catholic, but they also welcome non-Catholic students who may also become GRACE Scholars.





At St. Joseph Catholic Parish School, we work hard to provide access to a Catholic Education to as many families as we can. As a small school with limited resources, GRACE has been instrumental in making this happen and increasing our enrollment. This school year, we were able to welcome (31) of our (52) new students because of the GRACE Scholarship. One of the best things about the GRACE Scholarship is that students receive their award year after year, with demonstrated need. Because of this, GRACE recipients have nearly a 100% retention rate with us. GRACE has helped at least (100) students come to St. Joseph over the last three to four years - families who may otherwise think Catholic Education is out of reach. We are so grateful for the opportunity to work with GRACE to help fulfill the mission of our Catholic Schools.

In exchange for contributions to GRACE Scholars, donors receive a 100% state of Georgia income tax credit! It's a nobrainer.



Because there are limited tax credits available each year (\$120 million in 2023), a taxpayer who is interested in contributing to GRACE must be pre-approved by the Georgia Department of Revenue (DOR). This simply means that the DOR sets aside a certain amount of the available tax credits specifically for the respective taxpayer. When the donor submits their registration form, GRACE takes care of every remaining step and reminds the donor when action is required.



The number of parishioners has grown to nearly 1.3 million. We thank God for the opportunity to serve the increasing population of the archdiocese. However, the increased population of worshippers comes with challenges. People of different ethnic backgrounds, languages, races and age groups must be accommodated and served in various ways unique to them. Therefore, we need more priests and religious, as well as dedicated lay people to support our parishes and ministries. Fortunately, the challenges present opportunities if identified and appropriately addressed. The Archdiocese of Atlanta has developed a collaboration with the University of Dallas since 2013. At the request of the Archdiocese, the University's School of Ministry developed the online version of its *Certificado en Teología Pastoral*, restructured in the now *Certificado en Ministerio Pastoral*. The goal has been to support the parishes that offer Mass in Spanish by equipping the leaders, nominated by their pastor, with the necessary

The program is designed to provide essential pastoral and theological resources for those who volunteer or professionally dedicate their time to ministry. The Certificate program focuses on key areas of intellectual, human, and spiritual formation. Courses cover a wide range of topics (including Christian anthropology, ministry in a multicultural Church, morality, and social justice, the New Testament, prayer, and spirituality).

The Archdiocese's efforts have been supported and recognized by Atlanta pastors, religious and parish leaders, and at the national level by the then National Conference for Catechetical Leadership (now the National Community of Catechetical Leaders), who awarded the Archdiocese the 2017 Diocesan New Wineskins Award, acknowledging the effectiveness and the evangelizing and catechetical contribution of this initiative.

Students in this program have not only received excellent theological instruction in Spanish to reproduce and deliver formation at the parish; they have also experienced accompaniment, radical hospitality, fellowship, community, and spiritual formation. Graduates are serving in different ministries at the parish level, as directors of faith formation or religious education, catechists, youth ministers, and some are involved, as well, in initiatives at the diocesan level representing their parishes, such as the V Encuentro, the Eucharistic Revival, and other ministries.

A Letter From The Chief Financial Officer

Dear friends,

What a great time to be Catholic in the Archdiocese of Atlanta. As we grow in population and faith, our commitment to maintain best practices and financial strength must keep pace.

We are pleased to present our annual financial report in a format designed to give you transparency and insight into our stewardship of your gifts and of the temporal assets of the Roman Catholic Archdiocese of Atlanta and affiliated entities.

Our fiscal year ended June 30, 2022 and includes these significant events:

- As the pandemic waned and people returned to their parishes, your generous gifts of offertory rose nearly 10 percent.
- Our investments held in stocks and bonds dropped in value with the results reflected in the financial statements of several
 entities.

Various factors and multi-year trends are worthy of mention:

- Our pastors have recruited impressive members for their Parish Finance Councils which steward the use of your generous gifts. As a testament to this acumen and focus on stewardship, approximately 75percent of our parishes have no debt! Several parishes with debt are implementing the program Debt Free in 2023.
- All parishes have at least one endowment managed by the Catholic Foundation of North Georgia to enhance their longterm financial viability.
- We continue to grow. New parishes/missions such as St. John Paul II in Gainesville and St. Clare in Acworth have been established and are thriving.
- The stability of the archdiocese has improved in two very important ways. First, the funding status of the Priests' Pension increased from 52percent in 2012 to more than 106 percent this year. Second, as shown in the graph below, our outside debt decreased dramatically from nearly \$124 million in 2005 to only \$15 million today. This prudent capital structure allows for your gifts to fund ministry versus debt service to commercial banks.

In addition to the summary reports shown here, we post on our website the audited financial statements, including notes, for the eight most financially significant entities. We post compiled financial statements for two less-financially significant entities.

As a reminder, the financial results of parishes, missions, and parish-based schools publish their financial statements separately. We post their reports on the archdiocesan website and recommend that parishioners take time to review the online descriptions and understand the financial health of their parish.



Archdiocesan Finance Council

The Code of Canon Law of the Roman Catholic Church requires that the archbishop establish a Finance Council of the Christian Faithful who are experienced in finance, civil law and general business matters and who are persons of outstanding integrity. The archdiocesan Finance Council provides assistance and guidance to the archdishop in the administration of the temporal goods of the Archdiocese of Atlanta.

The Finance Council conducts its work through a committee structure. The chair of each committee must be a member of the Finance Council. Each committee may add members, from outside of the Finance Council, for needed expertise and insight.

The standing committees are: Audit (AC), Financial Planning and Analysis (FPA), Project Review (PRC), Investment (IC), Benefits (BC), Parish Support (PS), Development/Philanthropy (DP) and Compensation (CC).
