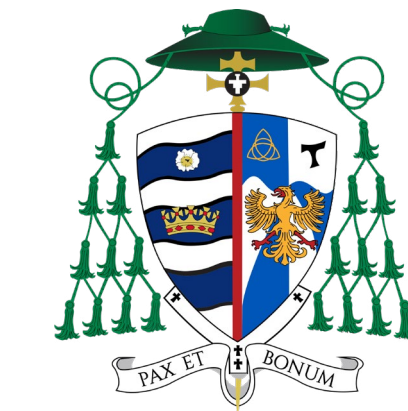

Office of Child and Youth Protection

The Office of Child & Youth Protection is responsible for implementing and overseeing the full archdiocesan compliance of the Charter for the Protection of Children and Young People (Charter). The Charter is a comprehensive set of procedures originally established by the United States Conference of Catholic Bishops (USCCB) in June 2002, for addressing allegations of sexual abuse of minors by Catholic clergy. The Charter also includes guidelines for reconciliation, healing, accountability and prevention of future acts of abuse.

To Promote Healing and Reconciliation with Victims/Survivors of Abuse
Part One

The wording of the Charter is very clear on the importance the bishops’ place on their responsibility to help victims’ healing and reconciliation. It states, “The first obligation of the Church with regard to the victims is for healing and reconciliation.” During 2024-2025*, healing outreach to victim/survivors in the Archdiocese of Atlanta included covering the cost of therapy, The Way Healing Retreats and the Trauma Recovery Group. Also, during 2024-2025*, ongoing healing outreach was provided for six (6) victims/survivors who reported abuse from previous audit periods.

To Guarantee an Effective Response to Allegations of Sexual Abuse of Minors
Part Two

All dioceses are to report all allegations of sexual abuse of minors to public authorities.** All clergy who have been found guilty or admitted guilt are permanently removed from ministry. There are clear standards of behavior and appropriate boundaries for all clergy, employees and volunteers. The Safe Environment policies are outlined on the archdiocesan website. In the spirit of transparency and the hope of continued healing for survivors of abuse, the archdiocese continues to update the published list on our webpage of priests, deacons, seminarians and religious credibly accused of sexual abuse of a minor as new information becomes available.

To Ensure the Accountability of Our Procedures
Part Three

The mission of the USCCB Committee for the Protection of Children and Young People is to advise the bishops on all matters related to child and youth protection. Each diocese has a review board to advise its bishop in his assessment of allegations of abuse by clergy and in his determination of an accused cleric’s suitability for ministry. The Archdiocese of Atlanta’s review board meets quarterly and is composed of at least five laypersons of integrity and good judgment in full communion with the Church. Furthermore, dioceses in the United States undergo an annual audit conducted by an outside auditor. In August 2025, the Archdiocese of Atlanta participated in a Charter compliance audit conducted by StoneBridge Business Partners. The auditors found the Archdiocese of Atlanta in full compliance with the Charter for the 19th straight year.

A national Annual Report on the implementation of the Charter, prepared and issued by the Secretariat of Child and Youth Protection for the National Review Board and the USCCB, provides an annual review of implementation statistics from all the dioceses in the United States. The Archdiocese of Atlanta also participated in the 2025 annual statistical data gathering by the Georgetown University-based Center for Applied Research in the Apostolate (CARA).

Part Four

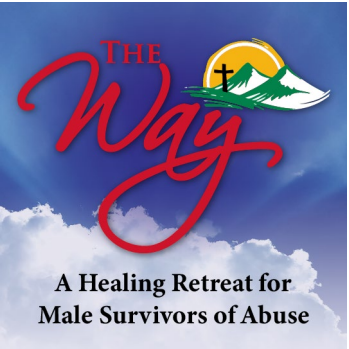
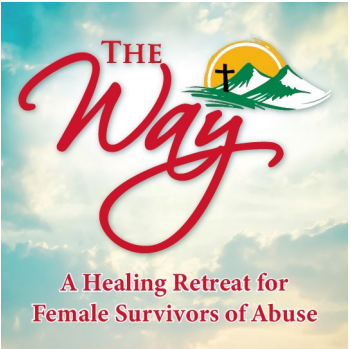
The Archdiocese of Atlanta trains clergy, employees and volunteers to create and maintain safe environments for children. The backgrounds of clergy, employees and volunteers were evaluated to determine if someone should not be allowed to minister to children and young people. During 2024-2025*, the Archdiocese of Atlanta trained 35,696 children in grades K-12 in archdiocesan Catholic schools and parish Religious Education programs through the age appropriate and faith-based program, VIRTUS Empowering God’s Children. In addition, more than 64,542 adults have attended VIRTUS Protecting God’s Children 3-hour, in-person training sessions in our Archdiocese.

Child Protection Efforts Costs

Compliance with the Charter represents a significant financial commitment in the Archdiocese of Atlanta. In 2024-2025*, within the Archdiocese of Atlanta, the cost of the various programs and measures outlined herein totaled \$517,321. The archdiocese also provided financial assistance to victims and their families for counseling services totaling \$12,480.

***All suspected child abuse must be reported to the Department of Family and Children Services (DFCS) 1-855-422-4453 (1-855-GA CHILD) and the supervisor of the parish or school (pastor or principal). If the allegation of abuse involves a member of the clergy, employee or volunteer of the Archdiocese of Atlanta, also contact the Office of Child and Youth Protection during business hours or use the archdiocesan 24-hour abuse reporting line at 1-888-437-0764. The silence must be broken for the healing to begin.*





The Life of the Church

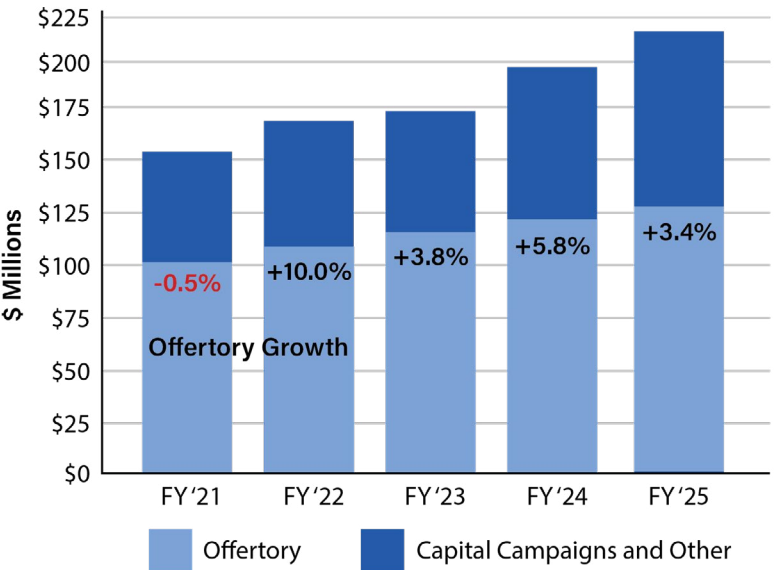
The parishes of the archdiocese are a wonderful tapestry of God’s people. Each has a unique history of clergy and religious, parishioners, staff and events. Our parishes are supported through the stewardship of their parishioners. Beginning with the realization that all gifts are from God, parishioners contribute their time, talent and treasure. The health of each parish has multiple facets, and this report focuses on only one, finances.

Each pastor is aided by a parish finance council to administer the financial affairs of the parish. Annually, each pastor and his parish finance council submit and certify their financial statements to the archbishop.

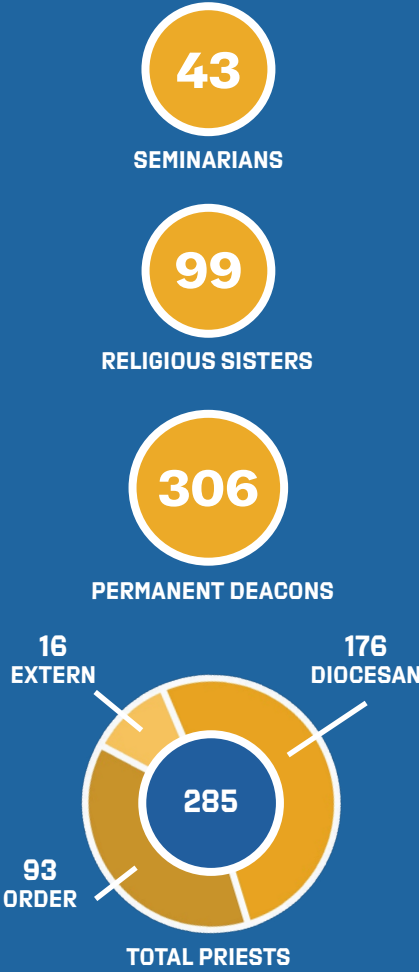
Each pastor and his parish finance council render a report to their parishioners on the financial condition of their parish. We collect these reports and post them on our website. Parishioners should take an active interest in understanding the administration of the temporal affairs of their parishes. Parish Income Trends

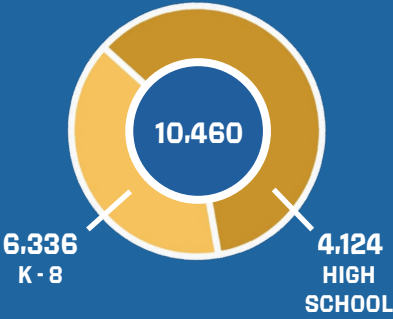
Years ending June 30



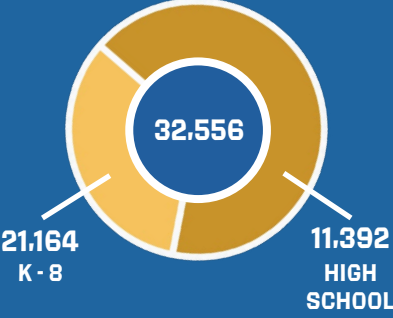
2025 CLERGY, RELIGIOUS AND SEMINARIANS IN SERVICE TO THE ARCHDIOCESE

A Parishioner’s Guide to Understanding Finances

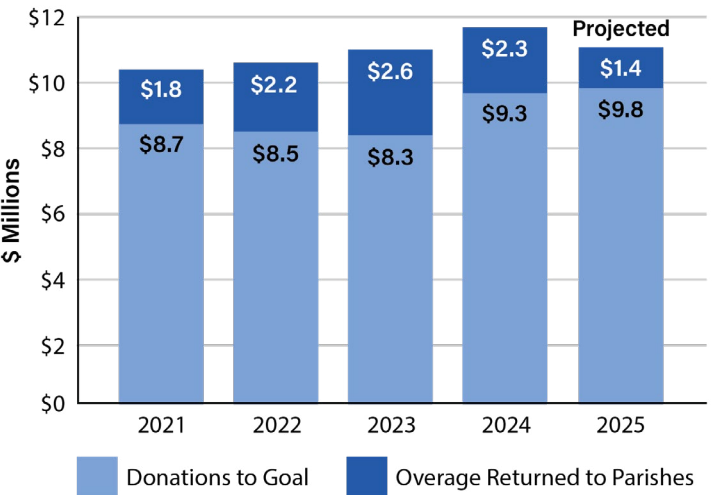
Stewardship is the responsibility of all parishioners. In order to be good stewards, parishioners should possess a basic understanding of parish financial operations. This understanding provides opportunities to further serve your parish.

The questions on the right are designed to assess your knowledge of parish finances and provide a guide for discussion with your parish leaders. While each can be answered with a “yes” or “no,” these questions are starting points for richer discussions about financial stewardship in the parish.

It is widely accepted that an active, well-informed parish finance council strengthens accountability and assists the pastor with his responsibilities. These questions pay particular attention to parish finance councils. Leadership Roundtable

1. Does my parish have a finance council?
2. Does my parish finance council meet regularly and are the members’ professional backgrounds appropriate for service on the finance council?
3. Does my parish/parish finance council publish the annual budget and are parish officials available to discuss the budget?
4. Does my parish routinely publish statistics including: number of registered parishioners, collection levels and school enrollment, along with an annual comprehensive financial statement that includes revenues, expenses and a balance sheet?
5. Does my parish include statistics from prior years for comparison and to identify trends?
6. Does my parish release quarterly or semi-annual “budget updates” that show actual revenues and expenses in comparison to the approved budget?
7. Does my parish have a rainy day or capital savings account?
8. Does my parish have policies on conflicts of interest and/or protection of whistleblowers as recommended by the United States Conference of Catholic Bishops Accounting Practices Committee?
9. Is there a regularly scheduled audit of the parish that is conducted by an independent outside auditor?
10. Is there an annual diocesan/parish questionnaire that assesses the parish’s financial controls and health? Is this document reviewed by the parish finance council and acted upon?
11. Are parish buildings inspected by a competent building inspector periodically for routine maintenance? Are the inspection results taken into account when budgeting?
12. Does my parish follow diocesan guidelines for handling offertory collections, such as rotating teams of collection counters?
13. Are there oversight policies for receipt/handling and disbursement of parish funds handled by individuals?
14. Are bank and other account statements received and reviewed independently by more than one individual?
15. Are the individuals handling financial responsibilities in my parish cross-trained so that if one becomes incapacitated, another may perform that function?

The Office of Planning and Research

WHO WE ARE

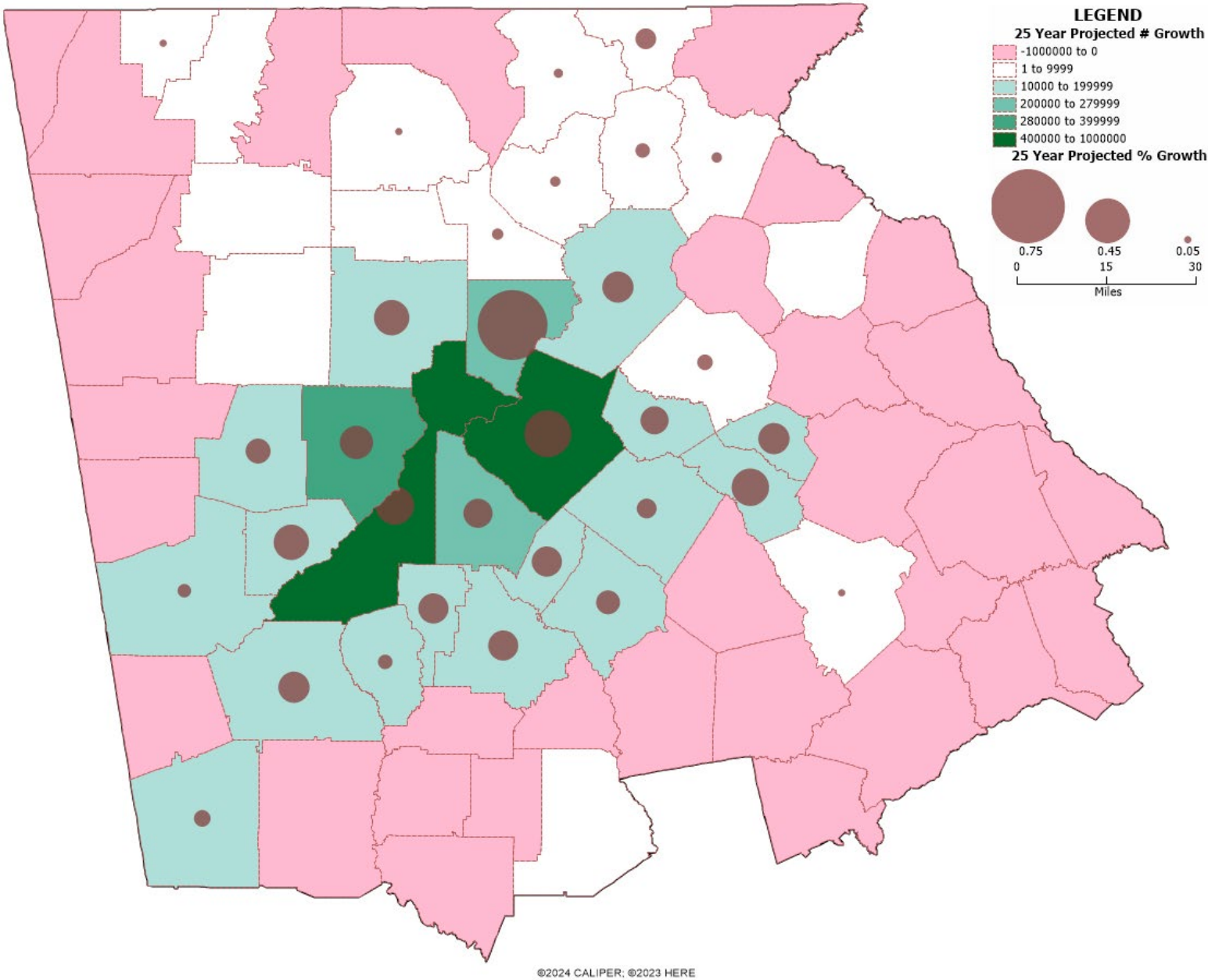
The Office of Planning and Research was created in 2008 to accommodate and strategically address the explosive growth and changing demographics in the Archdiocese of Atlanta.

VISION

To be a source of meaningful information that will enhance the archdiocese’s ability to identify the needs of local churches and respond strategically.

MISSION

To help the archdiocese and its parishes to understand trends impacting our mission by collecting, analyzing, and visualizing data from both internal and external sources.



Mass Counts

In October of every year, the Office of Planning and Research asks parishes and missions to track how many people attend Masses. This information provides another metric to understand and measure trends in our Catholic population as well as identifying which locations may have reached maximum capacity.

Maps

Using GIS Software, the Office of Planning and Research maintains the online boundary map so anyone can search addresses and find a parish. The office also portrays demographic data to visualize growth and identify gaps, such as projected growth hotspots compared to parish and mission locations.

Catholic Estimates

Many Catholics might not register or engage with a parish. The Office of Planning and Research uses census population, race and ethnicity counts to provide estimates of all that would identify as Catholic despite being disconnected. By comparing this data to registered Catholics, the office can estimate how many brothers and sisters might be reached and welcomed.

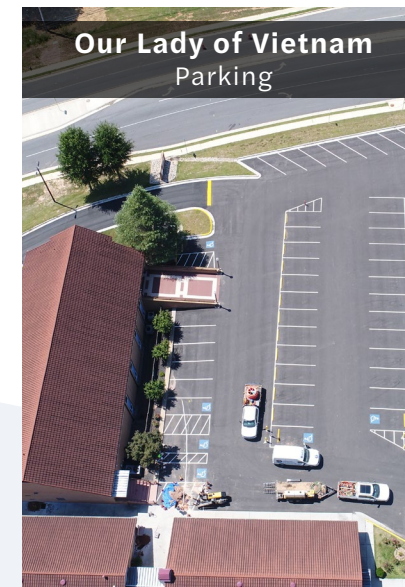

The Office of Archives and Records

Our Mission

Founded in 1992, the mission of the Office of Archives and Records is to collect, preserve and make available the permanent and official records of the Archdiocese of Atlanta, its people, institutions and associations. It documents the historical richness, development and the spiritual, temporal, and business affairs of the Catholic Church in North Georgia. It also supports the protection, administration and management of Archdiocesan records, based on legal and canonical statutes. To ensure that records management policies and procedures are appropriately met, the Office of Archives and Records assists archdiocesan entities in understanding, identifying and applying retention and disposition practices.

Per Canon Law, the responsibility for good stewardship of diocesan records and historical archives belongs to the Chancellor of a diocese. At the Archdiocese of Atlanta, the Chancellor has entrusted that responsibility to the Office of Archives and Records and has hired trained professionals to oversee and manage the process.

What We Do

The Office of Archives and Records is functionally divided up into two categories of work: archives and records management. These functions are very much related to each other as they both make up the life cycle of all records created within an organization. Our work is designed to help employees across the archdiocese manage their day-to-day work efficiently so that we ensure historical materials are being preserved for the future. A well-run records management program guarantees a robust archival collection because we make certain to keep what is important and dispose of what is not (when the appropriate time comes!).

Below is a sampling of the work of the Office of Archives and Records.

- Sacramental Records Information (e.g. how to write sacraments into the register, how to issue certificates, how to fix mistakes, where to find records, etc.)
- Reference Requests (internal and external research questions both simple/complex and digital/in-person)

- Transcript Requests
- Oral History Interviews
- Preservation Assistance
- Genealogy Research

Records Management Related

- Records and Email Management Training
- Records Retention Assistance (i.e. what to keep and for how long)
- Facilitating Records Disposition (i.e. permission to destroy records by shredding/deleting)
- Records Assessment Consultations for Departments, Parishes and Schools (e.g. evaluating storage conditions, purging past retention files, identifying permanent records, making organizational recommendations, etc.)
- Guidance on Managing Digital Records (including file-naming conventions and standards for abbreviations)
- Consulting and Collaborating with Chancery Departments on Software Projects/Databases (that impact records/information)
- Litigation Support for the Chancellor

During the course of the last 15 years, the staff of the Office of Archives and Records has improved and streamlined the work of the department and has cemented themselves (and thereby the Archdiocese of Atlanta) as go-to experts in the field of diocesan archives and records, regularly consulting with other archivists and chancellors at dioceses around the country.

The Villanova Center for Church and School Management

The Center for Church Management at the Villanova School of Business provides education and scholarship in the Augustinian Catholic tradition, helping church leaders to steward the human, financial and other resources of the church by teaching business best practices in a Christian context of mission and ministry.

For more than a decade, the Archdiocese of Atlanta has partnered with Villanova University to offer parish and school leaders resources to enhance knowledge and build administration skills. To date, 82 central and north Georgians have completed certification programs while working for archdiocesan parishes and schools. Our policy of reimbursing attendees for program costs has made this educational opportunity both accessible and affordable to all. Villanova University also offers scholarships to all our students.

Certificate in Catholic Church Management

The Certificate in Church Management is designed uniquely for Christian faith-based organizations. This 12-class online series teaches business best practices in the context of the Church, encouraging comprehension, reflection and application to help our Church leaders grow in support of their individual missions and the Great Commission.

Certificate in Catholic School Management

The certificate in Catholic School Management enhances management skills and deepens the spirit of leadership for Catholic school administrators. This self-paced, online certificate program equips school leaders with the tools they need to successfully guide our Catholic schools.

Master of Science in Church Management

Villanova offers the only Master of Science in Church Management, a holistic, integrated master’s program designed to provide Church leaders with a high-level skillset in Church management that strengthens their ability to contribute to the Church’s mission. The two-year master is taught online and is intended for full-time active ministers. Students from the Archdiocese of Atlanta automatically receive a scholarship for 50 percent of tuition costs, a \$14,700 value.

Certificate in Catholic School Management for Men in Formation

This one-week, in person Certificate in Church Management is designed specifically to educate men in formation (from two years before ordination to five years afterward). Taught on Villanova’s beautiful campus, the course covers organizational fundamentals that are not taught in seminary, exploring financial and people management through the lens of Catholic social thought. Participants learn to navigate some of the most common Church management challenges.

Office of Mission Advancement

The Office of Mission Advancement (OMA) plays a unique role in helping parishioners discover the joy of putting their faith into action. We achieve this by connecting them with opportunities that resonate with their hearts and advance the Church's mission.

We provide an extensive support system for parishes, schools, ministries and programs across the Archdiocese of Atlanta. We offer both general guidance and specific strategies and tools for implementation for:

Annual Appeal and second collections
stewardship and parish offertory
capital campaign and building fund solicitation
gift processing
domestic and international mission outreach
financial and analytical modeling
donor cultivation and analytics
marketing and promotions



The needs and challenges across one of the fastest-growing dioceses in the country are vast. OMA advances the mission of the Church by connecting the generous people of the archdiocese to projects and programs outside of their main parish, providing many opportunities to put their faith into action and serve one another in Christ. This collective effort has a profound impact on our community, making us all part of a larger mission.

The Office of Mission Advancement is proud to share the tangible results of our efforts in 2025. We are deeply grateful to the parishioners of the Archdiocese of Atlanta for their generosity, which has made these achievements possible:

- Launched our digital marketing initiative to provide timely communication of events, happenings and stewardship opportunities in the Archdiocese of Atlanta, as well as broadcast the many good works occurring throughout our community.
- Increased overages to the Annual Appeal by \$2.3 million. \$2.3 million returned to the parishes for their current and long-term needs.
- Supported the needs of 13 dioceses, three programs and three religious orders internationally and domestically in their work of evangelization and serving the poor through the Catholic Mission Outreach Second Collection program.
- Partnered with the Catholic Leadership Institute to begin Next Generation Parish. At no cost to parishes, those involved will receive support in addressing declining sacramental participation, changing societal norms and generational shifts in the Church.

Funded projects outside of the Annual Appeal collections include a wide variety of initiatives that are shaping the future of our Church:

- Provided a new van for the Sisters Poor of Jesus Christ at House of St. Katherine Drexel in Cedartown to continue their street ministry efforts.
- Funded the publication of Red Bird Ministries' Miscarriage Parent's Handbook and delivered copies to the 700 clergy of the archdiocese.
- Gained funding for FOCUS missionaries at the Kennesaw State University Catholic Center.
- Supported the space and security for 33 first-class relics at St. Paul the Apostle Catholic Church in Cleveland, Georgia.
- Aided the "Honoring Mary's Legacy" Fund at St. Mary Catholic Church in Toccoa to build and furnish a new parish life center, religious education center, clergy offices and the St. Mary prayer garden.
- Supported "For Such a Time as This," the first comprehensive interior restoration and redecoration project at the Basilica of the Sacred Heart of Jesus.
- Secured additional funding for the following:
 - Toni's Camp Retreat, a program of the Disabilities Ministry.
 - 160 Spanish Bibles to individuals in the Detention Unit at the Federal Correctional Institution, a program of the Prison Ministry.
 - Priests' Jubilarian dinner.
 - ECHO Young Adult Theology of the Body Retreat, a program of the Respect Life Ministry and the Office of Evangelization and Discipleship.

The Ann and Joe O. Neuhoﬀ Institute for Ministry & Evangelization

The Ann & Joe O. Neuhoﬀ Institute for Ministry & Evangelization (formerly School of Ministry) at the University of Dallas is immersed in the Catholic theological tradition and devoted to transformative, hands-on service to Christ and his Church. It oﬀers a wide variety of formation programs for students committed to pastoral service. Courses are oﬀered both in person and online. Teaching faculty have distinguished themselves academically and through professional leadership positions in national and international Catholic organizations. The Institute is committed to oﬀering students practice-oriented programs of theological studies and pastoral ministry that develop the critical thinking skills necessary for theological reflection, the practical skills for eﬀective leadership and the habits of mind needed to continue to grow in faith and service.

Certificado en Ministerio Pastoral (formerly known as Certificado en Teología Pastoral)

The Archdiocese of Atlanta has developed a collaboration with the University of Dallas since 2013. At the request of the archdiocese, the University’s School of Ministry developed the online version of its Certificado en Teología Pastoral, restructured in the now Certificado en Ministerio Pastoral. The goal has been to support parishes by equipping sponsorship seeking leaders, nominated by their pastor, with the necessary tools for the ministry of evangelization and catechesis.

The program is designed to provide essential pastoral and theological resources for those who volunteer or professionally dedicate their time to ministry. The certificate program focuses on key areas of intellectual, human and spiritual formation. Courses cover a wide range of topics (including Christian anthropology, ministry in a multicultural Church, morality, social justice, the New Testament, prayer and spirituality).

The archdiocese’s eﬀorts have been supported and recognized by Atlanta pastors, religious and parish leaders and, at the national level, by the then National Conference for Catechetical Leadership (now the National Community of Catechetical Leaders), who awarded the archdiocese the 2017 Diocesan New Wineskins Award, acknowledging the eﬀectiveness and the evangelizing and catechetical contribution of this initiative.

Students in this program have not only received excellent theological instruction in Spanish to reproduce and deliver formation at the parish; they have also experienced accompaniment, radical hospitality, fellowship, community and spiritual formation. Graduates are serving in diﬀerent ministries at the parish level, as directors of faith formation or religious education, catechists and youth ministers. Some are involved in initiatives at the diocesan level representing their parishes, such as the V Encuentro, the Eucharistic Revival and other ministries.

- Archdiocesan students currently enrolled in the Certificate in Pastoral Ministry: 62 (expected to receive their Certificate in the spring of 2028)
- Total Certificates awarded to archdiocesan participants since the partnership began in 2013: 305
- Nomination of new students to form a seventh, three-year cohort will open in May of 2028, to begin classes in the fall of 2028
- Total number of parishes that have benefited from forming Hispanic leaders: 55

It remains an exciting time to be a Catholic in the Archdiocese of Atlanta. As our faith community continues to grow in both size and spiritual vitality, our commitment to strong financial stewardship and best-practice governance remains unwavering.

We are pleased to present our annual financial report, which offers transparency and insight into how we manage the generous gifts you entrusted to us and how we safeguard the temporal assets of entities within the 69 counties comprising the Archdiocese of Atlanta.

Our fiscal year ended June 30, 2025 and includes these significant events:

Parish Contributions Grow:

You support your parishes generously! Offertory giving rose by 3.4 percent. Your contributions to parish capital campaigns remain at historic heights. These capital campaign funds are used to build new or renovate existing facilities supporting worship and ministries at your parishes. See page 6 of this report.

Prudent Use of Debt:

For major capital projects, parishes may borrow funds to begin construction while capital campaign pledges are collected over a period of years. Again, due to your generosity, only 23 of our 103 parishes have loans. The balance of all parish loans is less than \$22 million. While reasonable people may hold different views on the use of “prudent debt,” having the vast majority of our parishes debt-free allows more resources to support essential ministries. See pages 36-38 of this report.

Additionally—and with a grateful “hallelujah”—the final \$13 million payment was made to retire the municipal bond debt used to construct St. George Village, a full nine years ahead of schedule. We are now free from outside debt, which peaked at \$123 million just 25 years ago.

Investments Grow:

Our investments in stocks and bonds increased in value with the results reflected in the financial statements of several entities. Our balanced portfolios’ rates of return were approximately 10 percent. You will also see the positive investment returns when viewing the parish endowments which now total more than \$17 million. See pages 36-38 of this report.

Risk Insurance Program:

Our Risk Insurance Program covers property and liability exposures at more than 125 sites, representing more than \$1.9 billion in insured property value. The program emphasizes education, safety practices and regular facility inspections.

Our long-term loss ratio continues to outperform industry averages. Through a protected cell within a captive insurance company, the program retains and manages significant exposures prudently and cost-effectively.

Health Insurance Plan Stability:

Our Health Insurance Plan for 1,500 full-time employees, their dependents and our priests continues to perform well. Parishes will see only a 5 percent cost increase in the coming year, well below the increases typically seen in commercial plans.

Mission Expansion Fund Trust:

A 2017 article in The Georgia Bulletin, beautifully described how the archdiocese was committing resources to “...make room for everyone at the Lord’s table.”

To enhance contributions and strengthen governance, this program was restructured as a separate trust. The new Mission Expansion Fund Trust is reported separately on page 34 of this report.

Georgia Promise Scholarship Program:

In 2024, Georgia Governor Brian Kemp signed into law, through Senate Bill 233, the Georgia Promise Scholarship Program, which empowers families to pursue exceptional educational programs through non-public schooling, including Catholic schools. The scholarship award is \$6,500 per student which makes Catholic schools more affordable for many. All our Catholic schools can assist parents to avail themselves of this new school choice program. A word of thanks:

In response to the Archdiocesan Pastoral Plan, the Shared Accounting Services (SAS) team was created to support the financial operations of smaller parishes, missions and campus ministries. Led by Jack Husack, the SAS team now supports 53 parishes, missions and college campus ministries. The efforts of the SAS team have dramatically improved the financial operation of the institutions it supports.

In addition to the summary reports shown here, we post on our website the audited financial statements, including notes, for our nine most financially significant entities. We publish compiled financial statements for three less financially significant entities.

As a reminder, the financial results of parishes, missions and parish-based schools publish their financial statements separately. We post their reports on the archdiocesan website and recommend that parishioners take time to review the online descriptions and understand the financial health of their parish.

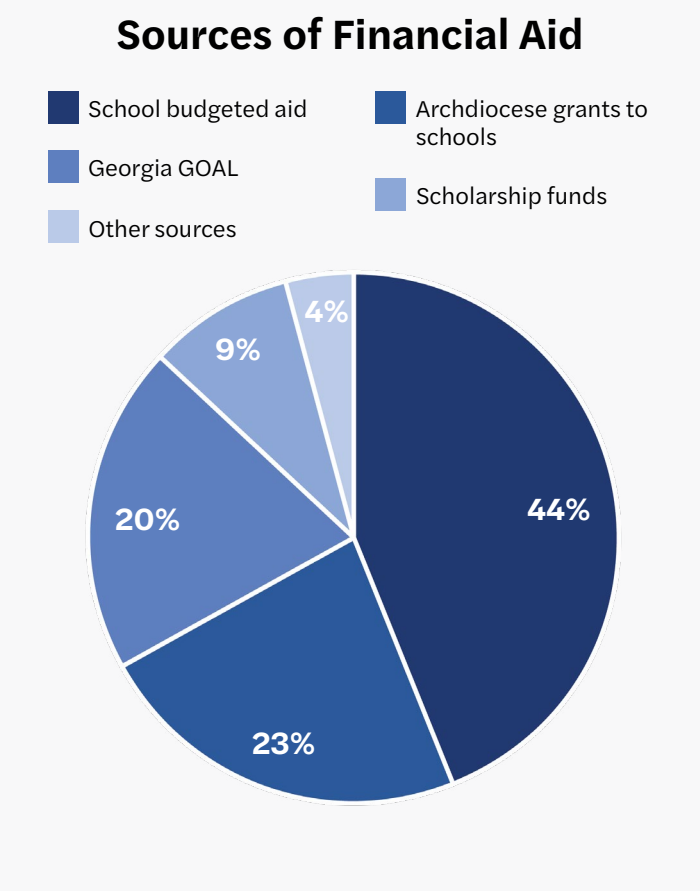

Serving Those who Serve Others

RCAA Administrative Services, Inc., (Services) formed in 2019 as a distinct entity, under both civil and canon law. Its purpose is to professionally manage and deliver administrative services to more than 120 entities (parishes, missions, schools, trusts, corporations, etc.) supporting the mission of the archdiocese.

Services operates independently and through service agreements with the **AoA Group Health Plan, LLC** and the **AoA Deposit and Loan Fund, LLC** to provide a comprehensive suite of services including: health insurance, treasury, risk insurance, retirement plans, parish support, accounting and other administrative services.

Health Insurance: Services is the plan sponsor for the Group Health Plan covering full-time lay employees, their dependents and our priests. This self-insured church plan continues to perform well.

Treasury: Treasury services include:

- 1. Maintaining banking relationships with two systemically important financial institutions to provide more than one hundred commercial checking accounts with positive pay and other fraud prevention tools.
- 2. Negotiates earnings credits to offset bank fees
- 3. Providing loans for capital projects
- 4. Investing short-term cash balances

Risk Insurance: Services manages a robust property and liability insurance program. Base coverages are procured through Catholic Mutual Group. Services is a member of a liability risk-sharing pool and engages Lloyd’s of London for specialty coverage. And finally, Services retains and manages substantial self-insurance exposures through its protected cell within a sponsored captive insurance company domiciled in Vermont.

Retirement Plans: Services is the plan sponsor for the three defined benefit plans for our priests:

- 1. Pension Plan
- 2. Long Term Care Plan
- 3. Medicare Supplement Plan

These three plans are fully funded and provide for our priest as they retire from a full-time assignment. The footnotes to the audited financials of Services provide actuarial details on the three plans. For our lay employees, Services sponsors a defined contribution plan, which beginning July 1, 2026, will change to a 403b plan.

Parish Support: The Parish Support Services team coordinates financial reporting and conducts internal audits of parishes and schools. This team also provides systems support for:

Archdiocesan
Finance Council

The Code of Canon Law of the Roman Catholic Church requires that the archbishop establish a finance council of the Christian faithful who are experienced in finance, civil law and general business matters and who are persons of outstanding integrity. The archdiocesan finance council provides assistance and guidance to the archbishop in the administration of the temporal goods of the Archdiocese of Atlanta.

The Finance and Advisory Council conducts its work through a committee structure. The chair of each committee must be a member of the finance council. Each committee may add members, from outside of the finance council, for needed expertise and insight.

The standing committees are: Audit (AC), Financial Planning and Analysis (FPAC), Project Review (PRC), Investment (IC), Benefits (BC) and Compensation (CC). The members of the Finance and Advisory Council, along with their parish affiliation and committee assignments, are:
