My Fellow Parishioners,

Alleluia! It is with joy and excitement that I am able to share with you our Annual Report for the fiscal year that ended June 30, 2019.

Your continued engagement, support and generosity shined in many areas. Your participation in the over 39 Adult Faith programs, the way you serve our parish and community, your attendance and involvement in daily and weekend masses along with your generous financial contributions are a blessing to witness.

The fruits of this commitment can be seen on the following pages is our Annual Report for the most recent fiscal year which ended on June 30, 2019. In addition to the financial reports, you will again find information on the number of sacraments celebrated, the number of parishioners serviced in faith formation and education programs along with a brief Parish history.

This past year our offertory income increased 4.4% or \$129,549 (total income increased 3.9%) more than the same period last year. Expenses increased 21.2% mostly due to capital expenses attributed to the renovations that were completed in the St. Faustina room and Loretto Hall. We were able to complete the renovations we have been discussing for two years in June of this year. The total expenses increased approximately \$638,255 of which \$593,915 was from the planned renovation expenses. Our budgeted income for next year is slightly less than what we received in 2018-2019. Our budgeted expenses are in line with the projected income and reflect increases needed to support and operate the parish. Since my arrival as your Pastor in February 2011, I have strived to be transparent with our Parish finances and diligent in managing our expenses by "living within our means". I hope you will take a few minutes to review the financial reports.

I am honored to continue serving as your Pastor and blessed to be supported by Fr. Pavol, a dedicated staff, terrific Deacons and you. Thank you for your support and contributions to our wonderful parish and community.

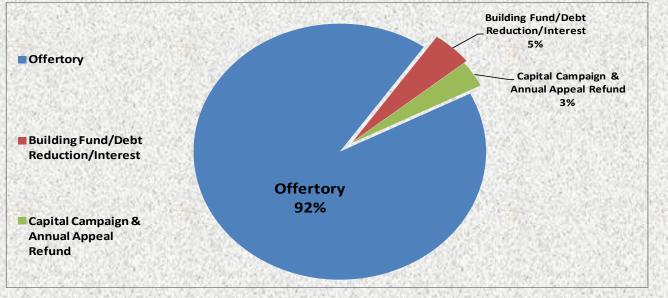

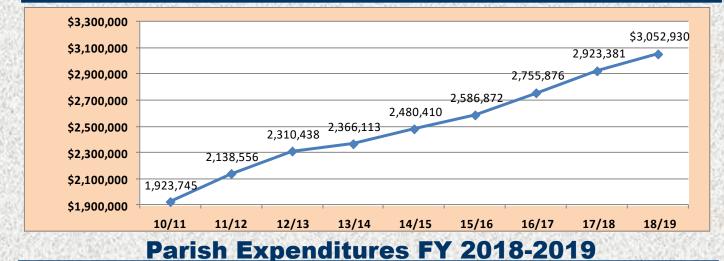

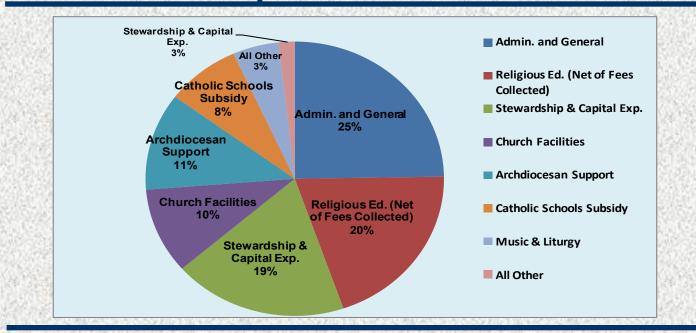
