#### HOLYTRINTY

My Fellow Parishioners,

I am delighted to continue to serve as your Pastor as I have done for the past 10 years and pleased to share with you the Annual Report for the fiscal year that ended June 30, 2021.

Before addressing some specifics of the report, I would like to say thank you for your continued prayers and support. These past eighteen months have been filled with a variety of challenges, uncertainty, and changes. During these unprecedented times we continue to strive to meet these challenges and remain focused on our mission. At Holy Trinity, our mission is that we are personally and communally called and challenged to be Christ for one another and to see Christ in one another through our commitment to active worship, education, and service. I am grateful for the efforts the staff, volunteers, and clergy have made and continue to make in serving the parish and community to fulfill our mission.

This past year our offertory income decreased -2.1% or (\$60,491) and total income decreased (\$130,569) or -3.6% for the same period last year. Your continued financial support and generosity is greatly appreciated. Due to the pandemic challenges and limited operations, expenses also decreased. Total expenses decreased (\$816,443) or -23% for the year. Part of the expense reduction (\$215,111) was the reduction of Catholic School Subsidy initiated by the Archdiocese of Atlanta. Although we did make some investments in technology to enhance our virtual capabilities, we were able to significantly reduce our operational expenses. We were vigilant in evaluating our spending and suspended as many discretionary expenses as possible which contributed to a reduction of (\$416,051) in expenses. As mentioned in previous reports, I strive to be transparent with our Parish finances and diligent in managing our expenses by "living within our means".

In this report you will find the financial reports, information on the number of sacraments that we were able to celebrate, the number of parishioners serviced in faith formation along with a brief Parish history.

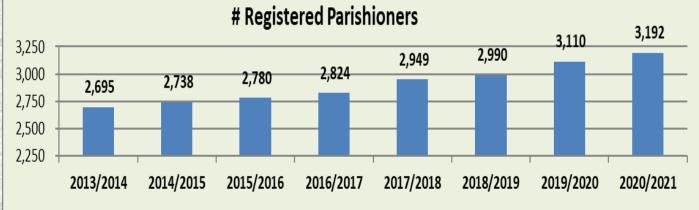

#### **Parish History**

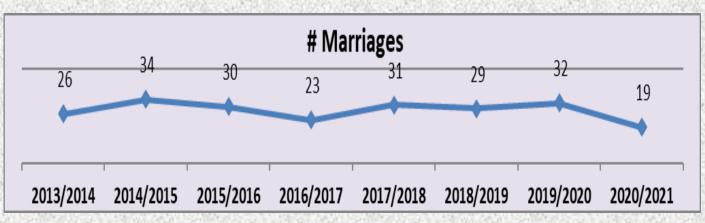
•	June 1973, 55 families petitioned Archbishop Donnellan to designate Holy Trini- ty as a mission.
	<ul> <li>For three years weekend Masses were held at Peachtree City Elemen- tary School.</li> </ul>
	<ul> <li>Masses at the school were followed by Masses at the Presbyterian Church, Aberdeen Information Center, cafeteria at the NCR company and finally at a warehouse shared with the Lutherans on Dividend Drive.</li> </ul>
•	November 1976, there were 180 parish families when the land of the current property was purchased.
	<ul> <li>In August 1977, the old rectory was constructed with office space, living quarters for the Pastor and enough lower level space for Mass and meet- ings.</li> </ul>
•	On December 7,1980 the church was completed and dedicated by Archbishop Donnellan.
•	1988 the parish built and dedicated Loretto Hall.
•	1996 remodeled and expanded the Sanctuary and also added the Nursery.
• 1 8	October 4, 2002 Archbishop Donoghue led a ground breaking Ceremony for the Faith Formation Building and current Rectory.
	August 2003. Construction of the current Rectory was completed.
	CY 2004. Construction of the Faith Formation building was completed.
	<ul> <li>Summer 2019. The renovation of Loretto Hall and St. Faustina Room was completed.</li> </ul>

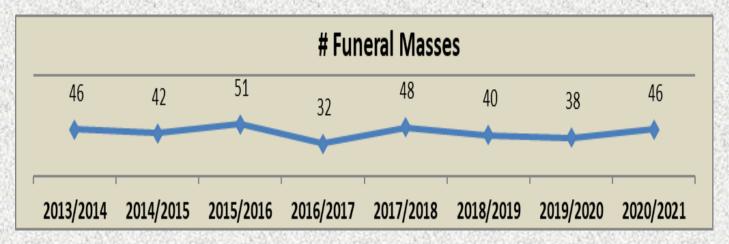

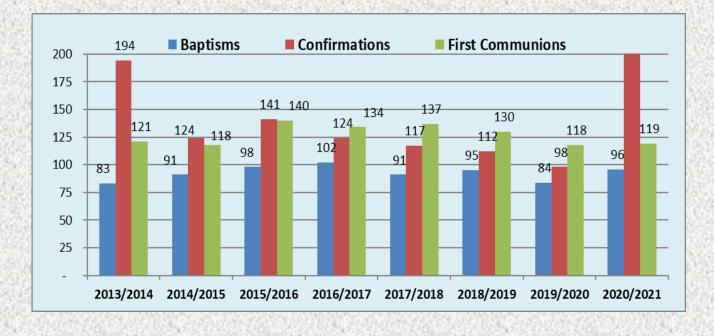
- Church seating capacity 586

- There are 26 Fire Extinguishers throughout the campus



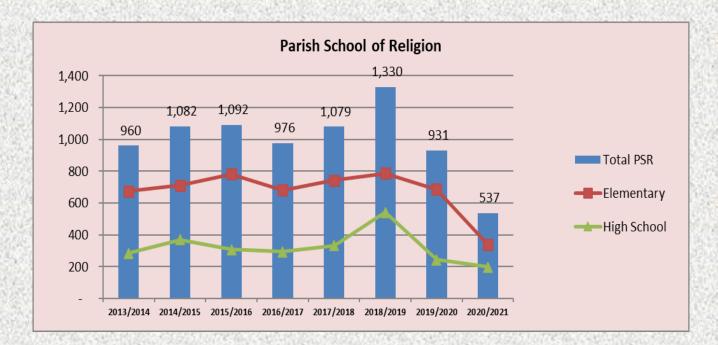

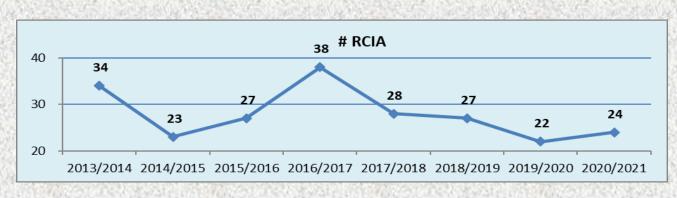


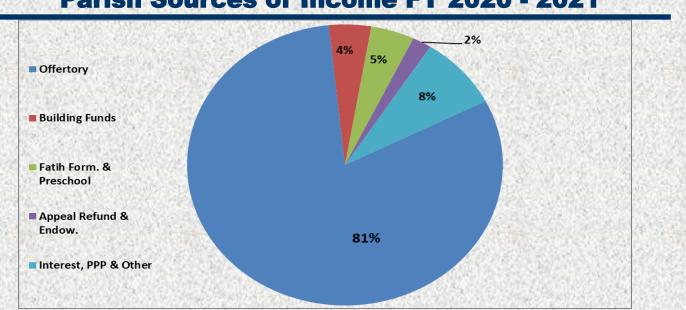

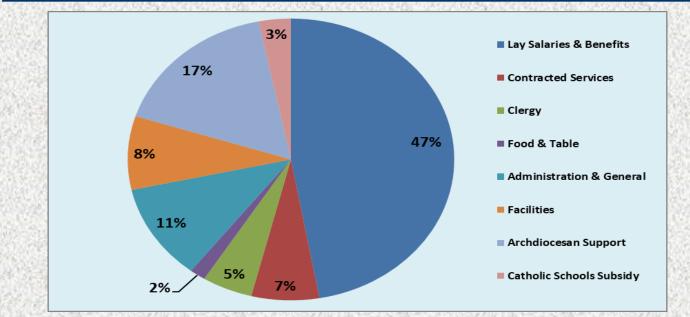


#### Parish Sources of Income FY 2020 - 2021

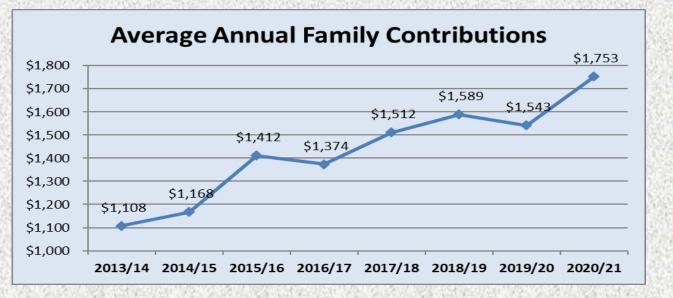
