Dear Saint Joseph Parish Family,

During the past fiscal year (July 1, 2016 – June 30, 2017), Capital Campaign contributions amounted to \$860,096. Payments made for new facilities, land improvements, and equipment amounted to \$48,613. The Archbishop's Annual Appeal for the current calendar year is \$59,600 of which \$48,746 has been collected to date.

The balance sheet as of June 30, 2017 remains positive with total assets of \$18,184,400 including cash balances of \$3,653,025. This balance is not a surplus, but instead supports the day-to-day operating expenses not met by the weekly offertory collection. Any balance will be used to complete the current phase of construction and to be applied to the building of the church. Included in the cash balances is \$2,947,536 set aside for our new church.
