Your generous donations to the Parish Debt Reduction Fund during the fiscal year of 2020/2021 along with the matching fund program from the Archdiocese of Atlanta, we were able to reduce our outstanding balance of non-interest General & School Assessment billing by a total of \$254,928. This was accomplished by your contributions of \$127,464 and the matching funds of the archdiocese for this same amount.

The outstanding balance of our non-interest Archdiocesan General & School Assessments as of 06/30/2021 is \$190,896. Through your continued generous support to the Parish Debt Reduction in the 2021-2022 fiscal year along with the \$100,000 matching fund program of the Archdiocese we will be able to clear this debt.

Major cost of replacement on AC/Hearing during this fiscal year was \$17,610 and updating expense on Wifi, Internet and phone was \$21,613.
